501 (c) 4

- September 18- Linda received phone call from IRS regarding status of 501 (c) 4. We've passed the first hurdle. Confirmed that the (4) category was appropriate for MPR EDC, based on past projects and current work plan. The status will start 3.9.23- date we filed the application (could not go back to 2011 formation). Next step is approval by supervisor- should happen by mid October. Decision on penalties are decided in a different department. Filing for the 501 (c) 4 and having completed tax returns, this agent said that we are now moving in the right direction.
- September 21- Received letter from IRS requesting 60 more days to review our March 15, 2023 letter requesting abatement of \$5,000 penalty.

Audit & Financial Statements

• October 2- Received our 3 year audit (FY 19,20 & 21). From now on, John Coggin, our CPA will be completing Compilation of Financial Statements. Linda forwarded copy of Audit to Cary. Also, if you are used to looking at "for-profit financial statements", they are a bit different than those done for non-profits. I found online an "ANAFP Guide to Understanding Non Profit Financial Statements". Project updates:

• City of Temple FM 2483 Corridor Master Plan

September 28- work started on the project on July 26. The project is to take 9 months to complete.
 September 29- Temple/MPR Wastewater Feasibility Study/ FM 2483 Masterplan- Invoices will come from Kasbert, Patrick & Associates, LP. Total project is \$15,000. We'll probably get monthly bills. EDC is making the first \$15,000 then the City will pay the remaining \$12,000+

- September 21- Linda discussed with Camille (New City Secretary) that we set up a file in the City Secretary's office for original EDC paperwork (Article Eight Amendment etc.). Still looking for the original EDC documents.
- September 27- Linda checked with Ophelia to see if MPR EDC is covered under City policy for Liability, Errors & Omissions Insurance. Good news- yes we are. Ophelia has a call into TML (Texas Municipal League) to see what exact coverage we have. We should look into a separate "Directors and Officers" Insurance policy and adding Cyber Liability and Security Breach coverage if it's not included under the city's policy. Per the policy, we need to include all "projects" in our minutes to make sure that they are covered for "wrongful acts".
