- Any recommendations to fill the empty seats starting January 1, 2024?

# 501 (c) 4

- Talked to Paula Malone, IRS case manager for our 501 (c) 4 application. Received first determination letter that the 501 (c) 4 status would be dated March 9, 2023 instead of 2011 since we didn't file for status within 3 years of formation, as required. There is also no record of the MPR EDC filing for Instrumentality 501 (a) status in 2011. Still waiting on IRS letter regarding filing late for 501 (c) 4 application.
- EDC needs to change articles of organization & bylaws to add 501 c 4 status (effective 3.9.23).
- November 6- Received Determination Letter in the mail. It's posted on EDC website and will be included in the City Council packet for their November meeting.

## **Financial Compilation**

- October 12- Linda signed John Coggin CPA Engagement letter to complete Financial Compilation for years ending Sept 30, 2022 and 2023. Cost is \$1,500.00 per year.

#### 990ez Taxes

will bring us currently. Still waiting on IRS letter regarding our late filing penalties. \$8,740 for 2021
and \$1,440 for 2022 (expected mid November)

  - City of Temple FM 2483 Corridor Master Plan
  - October 19- Linda met with Uryan (Interim City Manager). KPA Engineers met with property owners. Possible two idea solutions. Temple ends sewer system at MPR border (J & B Holdings Property #75866) or City of MPR donates property "to the cause" for a lift station.
  - **City Property above the marina.** (property ID#20976, 23.49 acres, commercial)
