PUBLIC HEARING

Item 2 Kleypas Park

Public hearing opened at 6:02 p.m.

President Tom Edwards informed the Council to apply for a Texas Parks & Wildlife Non-Urban Outdoor Recreation Grant in the amount of \$155,000, to be matched by funds allocated by the Morgan's Point Resort Economic Development Corporation combined with in-kind contributions from the City of Morgan's Point Resort for the purpose of implementing phase one of the Kleypas Park improvement plan described in the Morgan's Point Resort Master Park Plan. Mrs. Terri Leonhardt, 9 Wyatt Earp Drive, asked a question about the city's portion (\$100,000) and the EDC portion (\$70,706.60) for this grant process. Mrs. Leonhardt also inquired about the playground's installation cost and stated that the vendor should include installation cost in the total purchase amount. Mrs. Leonhardt also suggested that some work should be done on the tennis courts at the Kleypas Park.

Mr. Linda Cooper, 2 S Ebbtide Lane, informed the Council that special needs would gain a lot from the grant to allow the special needs to play on special playground equipment.

Mr. Gary Green, 6 Billy the Kid, informed the Council that it is a good idea for new playground equipment at Kleypas Park. Mr. Green expressed concern with the assembly of the new playground equipment – who would assemble it and stated that it would be best that the vendor assemble the equipment. Mr. Green suggested if any Council Members were going to attend the Texas Municipal League – visit the vendors at the exhibit hall for playground equipment.
