Discussion: Entrepreneurial Ecosystem will be included on the April 8, 2025 City Council workshop for discussion and on the regular agenda for a "yea or nay" of support for the project concept. Discussion: EDC recommends that the current Home Occupation ordinance be amended based on performance standards. City Council needs to decide on how restrictive the ordinance should be and what rules can be enforced. Recommend reviewing existing residential zone ordinances to see if they are currently too restrictive for both residents and resident business owners. No further input from EDC on a Home Ordinance amendment, City Council recommends all business owners and entrepreneurs be directed to the Federal government for ADA compliance.

Discussion: EDC is recommending the Tiny Business Village be built in stages. First stage to build a "model chalet" for residents and future tenants to have a visual on the project concept. Small events will be planned using pop up tents to represent future chalets. Grants, sponsorships and vendors will be recruited during this time. Future chalets will be built, based on a written commitment by an entrepreneur.
